

TERMS AND CONDITIONS: STANLEY INSTORE PRIZE DRAW PROMOTION AT BAUHAUS DENMARK. WIN A GARDEN SET CAMPAIGN

1. This prize draw promotion is open to all residents of in Denmark aged 18 or over, except employees of the promoter and Bauhaus and their respective immediate families, promoter's agencies and anyone else professionally connected with the promotion who are prohibited from entering this prize draw promotion. Winners will be required to provide proof of age.
2. Bauhaus stores may or may not display promotional point of sale.
3. To be eligible to participate in the promotion, the participant must purchase any STANLEY V20 product, at a BAUHAUS retail store in Denmark, on or between 1 May 2026 and 30 June 2026.
4. To enter, the participant must complete the required fields in the promotion entry form at <https://www.stanleytools.eu/dk/winthebox/> and upload a copy of their purchase receipt. These terms and conditions apply to all participants entered into this prize draw promotion.
