

**TERMS AND CONDITIONS: STANLEY INSTORE PRIZE DRAW PROMOTION IN NORWAY.
WIN A GARDEN SET CAMPAIGN**

1. This prize draw promotion is open to all residents of in Norway aged 18 or over, except employees of the promoter and participating customers and their respective immediate families, promoter's agencies and anyone else professionally connected with the promotion who are prohibited from entering this prize draw promotion. 3. To be eligible to participate in the promotion, the participant must purchase any STANLEY V20 product, at a participating customer in Norway, on or between 10 April 2026 and 30 May 2026.
